### **IFAS Constitutional Amendment Vote**

**PRESENTING AMENDMENT** 



### **Amendment Process**

Proposed amendment(s) shall be submitted in writing by the Secretary of the Faculty Assembly to the faculty at least two (2) weeks before a regular or special Faculty Assembly meeting to consider said amendments. The Faculty Assembly will decide by majority vote whether the proposed amendment will be referred to the faculty for a vote. Constitutional amendments may only be considered at Faculty Assembly meetings scheduled during the academic year.

This Constitution may be amended by a two-thirds vote of the IFAS faculty who vote on the amendment provided that notice and the text of the proposed amendment(s) are sent to the faculty by the Secretary at least 20 business days prior to the date of the faculty referendum on the proposed amendment(s). Amendments shall become immediately effective when written notice of the adopted changes is sent from the Chair of the Faculty Assembly to all members of the faculty. Such notice must be given within 10 business days of the date the vote is recorded.



### **Amendment Timeline**

- Amendment document will be email to assembly members at least three in advanced of February's meeting
- A vote will be taken on whether the amendment will be sent out to all eligible IFAS faculty. A 50% + 1 is needed to pass.
- If passed, then an electronic ballot will be sent out in advance of our March assembly meeting. A 2/3 majority is needed to pass.



### **Constitutional Amendment**

Section 4 – New Faculty

Searches for tenure-track or tenured faculty shall be conducted by the department or school in which the faculty member will hold academic rank. The department chair or school director shall appoint a Search and Screen Committee consistent with IFAS and university guidelines and ensuring a balanced representation of the department, school or center. After candidate interviews the Search and Screen Committee shall present to the chair or director a non-ranked list of recommended candidates with comments indicating the candidates' strengths and weaknesses, and the faculty of the unit may do likewise in accordance with unit-level shared governance practices. After conferring with the Search and Screen Committee, the unit faculty and deans, the chair or director shall make the appointment to the position.



### **Proposed Amendment**

#### Section 4 - New Faculty

Searches for tenure-track or tenured faculty shall be conducted by Method 1 for a campus- based faculty member or Method 2 for a REC-based faculty member:

#### Method 1:

Searches for tenure-track or tenured campus-based faculty shall be conducted by the department or school in which the faculty member will hold academic rank. The department chair or school director shall appoint a Search and Screen Committee consistent with IFAS and university guidelines and ensuring a balanced representation of the department, school or center. After candidate interviews the Search and Screen Committee shall present to the chair or director a non-ranked list of recommended candidates with comments indicating the candidates' strengths and weaknesses, and the faculty of the unit may do likewise in accordance with unit-level shared governance practices. After conferring with the Search and Screen Committee, and the department or school faculty and deans, the chair or director shall make the appointment to the position.

#### Method 2:

Searches for tenure-track or tenured REC-based faculty shall be conducted by the REC in collaboration with the department or school in which the faculty member will be tenured. The Center Director shall appoint a Search and Screen Committee consistent with IFAS and university guidelines and with recommendations from the Department Chair to ensure a balanced representation of the REC, department, school or center. After candidate interviews the Search and Screen Committee shall present to the Center Director a non-ranked list of recommended candidates with comments indicating the candidates' strengths and weaknesses, and the faculty of the REC and Department may do likewise in accordance with unit-level shared governance practices. After conferring with the Search and Screen Committee, and the REC and Department faculty, the Department Chair and deans, the Center Director shall make the appointment to the position.
